IOAC Action Plan / Action Taken Report

After the visit of NAAC peer team in the University March 2023, the gap areas have been identified and following corrective measures are taken

Criteria 1. Corrective measures to improve the rating under criterion 1

- New courses have been introduced on the university campus under NEP, including BBA, B.Sc. Agriculture, B.Sc. Zoology (hon), B.Sc. Physics, and B.Com.
- Field projects, Research projects and internships have been introduced in the newly introduced courses as per NEP guidelines
- To enhance employability, entrepreneurship, and skill development among the students, the curriculum has been modified accordingly.

Criteria 2. Corrective measures to improve the rating under criterion 2

Advanced teaching methods that are learner-centred, such as experiential learning, participative learning, and other self-learning methods, are used to make teaching and learning simple and effective. By making learning more individualized, creative, and dynamic, better outcomes are expected. Few proposed corrective measures

- Departments are being strengthened for special programs to address learner needs, including the
 use of ICT tools in everyday teaching and the incorporation of IT tools and management systems
 at the university level.
- · Attempts are being made in direction of filling of vacant faculty positions.
- Efforts are being made to align all teaching activities, ICT-mediated resources, and pedagogy for
 the overall benefit of the students. All departments are encouraged to include more such teaching
 pedagogy with related data management systems; incorporation of Swyam/ MOOCS in
 university.
- Students' Academic support systems, as prescribed in NEP and MERU guidelines, are being adopted, including the incorporation of NEQF, NCrF, Etc.

Criteria 3. Corrective measures to improve the rating under criterion 3

- University has made budgetary provisions of Rs 2.3 Crores to promote research activities like seed money, fellowship, equipments, publications, travel grants etc.
- Incentives are being proposed for promoting publications and patents.
- Receiving consultancy services orders now.
- Funding seed money to teachers from University fund for research
- · Numbers of publications have increased this year.
- Created ORCID and Vidwan ID of teachers and researchers for better outreach of their publications for more citations.

A Library Automation

Central Library is partially automated with the cloud based software e-Granthalaya V 4.0 developed by NIC.

Total 55769 book records of title 36350, 39 e-resources, 279 e-book (under Internet Resources). The book reservation and issue-return is initiated, and out of total of 519 Central Library members, 324 have started using e-Granthalaya. (Report of Issue-Return status is enclosed: Annexure-1)

 Complete library automation based on the RFID system is proposed and is in the procurement process.

C. Purchase of print Books, e-books, Print Journals and e-journals

- A Library Purchase committee is being formed for the purchase of print and digital Books and journals
- The purchasing of books has been started after the recommendation of books by the Department.

Criteria 5: Corrective measures to improve the rating under criterion 5

Corrective measures to address the lacunae

- Graduation-level students are being counseled in both organized and unorganized forms through personal communications between students and mentors and an organizing workshop for the same.
- The university has initiated a few non-professional undergraduate courses [eg. B.Com. (Hons.), B.Sc. Zoology (Hons.), etc.] and we expect to see an improved enrollment ratio for higher studies.

- The drive has been initiated to connect more alumni and obtain their support.

Critera 6: Corrective measures to improve the rating under criteria 6

The welfare practices for the well-being of teaching and non-teaching staff adapted are as follows:
