**Qualifications:** Eligibility criteria for Engineering: Bachelor of Technology (B.Tech) or Bachelor of Engineering (B.E) with specialization in Computer Science; Allied Computer Science streams, Information Technology, and all Circuital branches. Master of Technology (M.Tech) or Integrated Master of Technology (5 years MTech) with specialization in Computer Science; Allied Computer Science streams and Information Technology. Master of Computer Application. The year of graduation should be **2025**. Aggregate of **60% or equivalent** CGPA and above in current degree with **no active backlog**.

**Eligibility criteria for Undergrad (UG) :** UG Computer Science/Computer Application and allied - Bachelor of Computer Application (BCA), Bachelor of Science (BSc) - any combination with Computer Science / IT/Cyber Security.
